

OFFICIAL RULES OF THE PROMOTIONAL CAMPAIGN
“AnimaWings Raffle at Inspiring Women In Business”

Campaign period: 23 April 2026, during the *Inspiring Women In Business* event (18:00 – 21:00)

SECTION 1. ORGANIZER AND OFFICIAL RULES

The organizer of the promotional campaign **“AnimaWings Raffle at Inspiring Women In Business”** is **ANIMA WINGS AVIATION S.A.**, with registered office in Bucharest, Piața Alba Iulia no. 5, Mezzanine, Building I4, District 3, registered with the Trade Registry under no. J2024009018404, VAT no. RO41404510 (hereinafter referred to as the **“Organizer”**).

All participants in this campaign are required to comply with these terms and conditions (the **“Official Rules”**).

The Organizer reserves the right to amend these Official Rules, with any amendments becoming effective only after prior notice is published on the above-mentioned website.

SECTION 2. CAMPAIGN LOCATION

The campaign is organized and conducted physically during the *Inspiring Women In Business* event, held on **23 April 2026**, in accordance with these Official Rules.

SECTION 3. CAMPAIGN PERIOD

The campaign starts on **23 April 2026 at 18:00** and will run physically during the event (the **“Campaign Period”**).

Entries submitted before or after the Campaign Period will not be considered valid.

The Organizer reserves the right to modify the campaign end date, subject to publication of an addendum to these Rules.

SECTION 4. ELIGIBILITY

The campaign is open to any natural person who:

- is at least **18 years old** at the start date of the campaign;
- accepts these Official Rules;
- attends the *Inspiring Women In Business* event on **23 April 2026** during the Campaign Period.

Employees of the Organizer, involved collaborators, and their immediate family members (children, parents, siblings, spouse) are not eligible to participate.

Participation implies full, express and unconditional acceptance of these Official Rules.

The Organizer reserves the right to disqualify any participant who does not comply with these Rules or who is suspected of fraud, without the obligation to provide evidence.

SECTION 5. CAMPAIGN MECHANISM AND PRIZE

To be entered into the raffle, participants must complete **all** of the following steps:

1. Attend the *Inspiring Women In Business* event on **23 April 2026**.
2. Complete the online newsletter subscription form and provide consent to receive email communications by checking the relevant consent box.

Prize

SECTION 6. WINNER SELECTION AND VALIDATION

6.1 Prize Draw

The winner will be selected by random draw from all eligible participants based on the newsletter subscription database on **24 April 2026 by 16:30**.

The draw will take place after the event at the Organizer's headquarters.

6.2 Prize Claim

The selected winner will be contacted using the contact details provided in the newsletter subscription form.

SECTION 7. WINNER ANNOUNCEMENT

The validated winner's name and prize details will be communicated by email and/or phone using the contact information provided by the participant.

The winner's name may also be published in accordance with applicable Romanian legal requirements.

SECTION 8. TAXES AND COSTS

Any taxes due in connection with the prize, where applicable under Romanian law, will be calculated, withheld and paid by the Organizer.

Participants will not incur any additional indirect costs, except normal expenses related to attending the event (transportation, personal expenses, etc.).

SECTION 9. LIMITATION OF LIABILITY

Entries submitted outside the Campaign Period will not be considered.

The Organizer shall not be liable for:

- incomplete, incorrect or invalid entries;
- subscription forms not finalized through email confirmation;
- technical errors, internet issues, platform malfunctions or email provider failures;
- confirmation emails not received or redirected to spam/junk folders;
- damages suffered by participants resulting from participation or use of the prize;
- inaccurate or incomplete participant data;
- inability to contact winners due to incorrect contact details;
- loss of participation or prize claim rights due to failure to comply with these Rules.

The Organizer reserves the right to invalidate any entry that does not comply with these Rules or appears fraudulent.

SECTION 10. DATA PROTECTION

The Organizer processes participants' personal data in accordance with **EU Regulation 2016/679 (GDPR)** and applicable Romanian legislation.

Personal data collected in connection with this campaign will be used for campaign administration and may be shared only with contractual partners involved in campaign execution or where required by law.

SECTION 11. DISPUTES

If no amicable settlement is possible, disputes shall be referred to the competent Romanian courts.

Any complaints regarding the campaign must be submitted within **2 (two) days** from the campaign end date to the Organizer's registered address.

After this deadline, no claims will be considered.

SECTION 12. FORCE MAJEURE

Force majeure means any unforeseeable event beyond the Organizer's reasonable control which prevents fulfillment of obligations under these Rules.

In such cases, the Organizer shall be exempt from liability for the duration of the force majeure event and will notify participants within **5 working days** of its occurrence.
